1. **INTRODUCTION**

1.1 The Secretariat submits herewith its proposals for the ANC work programme for the 175th Session for consideration by the Air Navigation Commission. The list of items is presented in accordance with the relevant Strategic Objectives in the appendix.

2. **DRAFT WORK PROGRAMME**

2.1 The Commission (99-5) agreed that in the formulation of sessional work programmes close attention should be given to workload implications in order to ensure that the programmes can normally be handled by a schedule of three meetings weekly (including working group meetings).

2.2 The work programme is reviewed at the beginning of each session to determine whether any amendments are required to reflect carry-over items, Commission or Council action, or other developments since the formulation of the work programme.

3. **PRIORITY OF ITEMS**

3.1 It is standing practice for the Commission to determine whether any tasks require special priority in scheduling during the next session. The Secretariat proposes that high priority in scheduling should be accorded to items relating to the 36th Session of the assembly, as well as any items referred to the Commission by the Council.

4. INFORMAL BRIEFING

4.1 The Secretariat proposes an informal briefing on progress on activities relating to performance-based navigation (PBN). The briefing would be presented by Mr. E. Lassooij and would inform the Commission of work carried out with the assistance of the Required Navigation Performance and Special Operational Requirements Study Group (RNPSORSG).

5. OPENING AND CLOSING DATES FOR THE ANC'S 175TH SESSION AND RECESS DURING THE SESSION

5.1 The existing programme of ICAO meetings for 2007 (Electronic Bulletin A 13/4.07-07/2) provides the following schedule for the 175th Session of the Commission:

Opening date — 16 April 2007

Closing date — 22 June 2007

It is suggested that this schedule be maintained and that a recess be scheduled from 7 to 18 May 2007. This takes into account the planned termination date of the Council Committee phase on 4 May 2007 and commencement date of the Council phase on 22 May 2007.

6. PARTICIPATION BY INTERNATIONAL ORGANIZATIONS OTHER THAN THOSE WHICH HAVE A STANDING INVITATION

Pursuant to the Commission's request (139-16 (Closed)), the Secretariat has examined the work programme for the 175th Session with a view to identifying items for which an invitation may be extended to international organizations, other than those organizations to which standing invitations have been extended. No such item has been identified for the 175th Session.

In accordance with the new procedure concerning the participation of Airports Council International (ACI) as an observer in the discussion of certain items in the Commission (ANC 173-3 (closed)), the work programme will be provided to that organization following its approval by Council with a request that ACI indicate in which items it may wish to participate as observer.

7. ACTION BY THE AIR NAVIGATION COMMISSION

- 7.1 The Air Navigation Commission is invited to:
 - a) approve, for submission to the Council, the attached draft work programme for the 175th Session;
 - b) agree that the tasks identified in paragraph 3.1 be accorded high priority in scheduling;
 - c) agree that an informal briefing be scheduled on progress on activities relating to performance-based navigation (PBN);
 - d) approve the meeting schedule for the 175th Session from 16 April to 22 June 2007 with a recess from 7 to 18 May 2007; and
 - e) authorize the ANC President to approve the draft report to Council on the subject.
